Rules and Regulations

- 1) Completed entries and payment must be postmarked by August 1st of 2010 to avoid late charges. Entry fees are \$100.00 for females and \$25.00 for steers. The late charges are \$25 for females and \$10 for steers. Late entries will not be included in the Sale Catalog.
- 2) All Animals sell under the Standard Breeding Guarantee as endorsed by the American Shorthorn Association.
- 3) All Animals sold must meet physical inspection of the sale sifting committee. The committee will verify tattoos. Please have your animals tattooed prior to arrival.
- 4) Females must be registered with the American Shorthorn Association with proof no later than August 1st, 2010. All females must have original registration papers with transferred sections filled out and signed on file with the Sales Committee by Friday, October 29th, 2010. Females born before May 1st of the prior year must be vet checked with certification bred.
- 5) Females must be free of genetic defects recognized by the breed, currently TH & PH. If an animal has suspected parentage, they must be certified non carriers by test in order to sell at the Spotlight on Quality sale.
- 6) Steers must be colored Red, White or Roan and look Shorthorn.
- 7) All females must be calfhood vaccinated.
- 8) Photos of consignments, if you choose to provide them, are due to CSBA by August 15th, 2010.
- 9) Please use one entry form per female entry and one entry form for all steers.
- 10) No entries accepted via fax or email as check must accompany completed entry form.
- 11) Entry forms that are not complete, will not be accepted.
- 12) Commission will be charged at the rate of 7% for steers and 8% for females.
- 13) Animals must be in place by Friday at 5:00 p.m.
- 14) Cattle will be graded in the Show of Sale Cattle to help Sale Committee determine sale order.
- 15) Consignors having "no sales" must pay commission at the price announced by the Auctioneer.
- 16) Substitutes will be allowed if legitimate and at the sole discretion of the CSBA Sales Committee. Substitutes need to be turned in by the weekend before the sale.
- 17) Consignors must be members of the California Shorthorn Breeders' Association or the California Junior Shorthorn Association.
- 18) Consignors will be responsible for their cattle until delivery arrangements have been made.
- 19) By entering the sale and offering their consignments, Consignors agree to expressly indemnify, defend, and hold harmless the California Shorthorn Breeders' Association, its Spotlight on Quality Sale, its officers, directors, employees, agents, volunteers and assigns for any claim arising out of or incident to their participation in the sale, unless the claim is caused by sole negligence or willful misconduct of the CSBA. Consignors also understand that the CSBA does not provide any medical or dental insurance or life insurance to cover bodily injury, illness or death, nor insurance for personal property damage or loss, nor insurance for liability arising out of their negligent acts or omissions; and they acknowledge that they are completely responsible for their own insurance to cover these expenses. Consignors further understand that this acknowledgment of risk and hold harmless is intended to be as broad and inclusive as permitted by the laws of the State of California and that if any portion hereof is held invalid, the Consignor agrees that the balance shall, notwithstanding, continue in full legal force and effect.
