## CSBA Spotlight on Quality Sale Rules

\*\*\* Completed entries with quality pictures of consignments and payment \*\*\*
must be received by Sept. 13, 2023 to avoid late charges.

- 1) Entry fees are \$100 for females and \$25 for steers. The late entry fees are \$200 for females and \$50 for steers admitted upon approval of the sale committee. Late entries will not be included in the Sale Catalog.
- 2) All animals sell under the Standard Breeding Guarantee as endorsed by the American Shorthorn Association.
- 3) All animals sold must meet physical inspection of the sale sifting committee.
- 4) The committee will verify tattoos. Please have your animals tattooed prior to arrival.
- 5) Females must be registered purebred with the American Shorthorn Association and consignment entries must include copies of the registration papers. No ShorthornPlus Females (green papers) will be admitted.
- 6) All females must have original registration papers with transferred sections filled out and signed on file with the Sale Committee by the Friday of the sale weekend.
- 7) Females born before May 1<sup>st</sup> of the prior year (May 1, 2022) must be vet checked with certification bred within the 30 days prior to the sale.
- 8) Females born before Sept 1, 2021 must be inspected by the Sale Committee prior to entry to the sale.
- 9) Females must be free of genetic conditions recognized by the American Shorthorn Association. If an animal has suspected percentage per ASA pedigree, they must be certified non-carriers by test in order to sell at the Spotlight on Quality Sale. All genetic testing is the responsibility of the consignor.
- 10) Steers must be registered with the American Shorthorn Association, a minimum of 50% Shorthorn, and consignment entries must include copies of registration papers. All steers must have original papers with transferred sections filled out and signed on file with the Sale Committee by Friday of the sale weekend.
- 11) All females must be calf hood vaccinated before arrival.
- 12) Please use one entry form per animal (except for steers) and submit a quality picture with your entries (via email to amandagipe@gmail.com).
- 13) Entries may be received via email, but check must be received for the entry to be officially accepted.
- 14) Entry forms that are not complete will not be accepted.
- 15) Commission will be charged at the rate of 7% for steers and 8% for females.
- 16) Animals must be in place by Friday at 5:00 p.m.
- 17) Cattle will be graded in the Show of Sale Cattle to help Sale Committee determine sale order.
- 18) Consignors having "no sales" must pay commission at the price announced by the Auctioneer.
- 19) Substitutes will be allowed if legitimate and at the sole discretion of the CSBA Sales Committee. Substitutes need to be turned in by the weekend before the sale.
- 20) Consignors must be members of the California Shorthorn Breeders' Association or the California Junior Shorthorn Association.
- 21) Consignors will be responsible for their cattle until delivery arrangements have been made.
- 22) Consignors will request a copy of the Bill of Sale from buyer prior to releasing animals to buyer.
- 23) By entering the sale and offering their consignments, Consignors agree to expressly indemnify, defend, and hold harmless the California Shorthorn Breeders' Association, its Spotlight on Quality Sale, its officers, directors, employees, agents, volunteers, and assigns for any claim arising out of or incident to their participation in the sale, unless the claim is caused by sole negligence or willful misconduct of the CSBA. Consignors also understand that the CSBA does not provide any medical or dental or life insurance to cover bodily injury, illness or death, nor insurance for personal property damage or loss nor insurance for liability arising out of their negligent acts or omissions; and they acknowledge that they are completely responsible for their own insurance to cover these expenses. Consignors further understand that this acknowledgment of risk and hold harmless is intended to be as broad and inclusive as permitted by the laws of the State of California and that if any portion hereof is held invalid, the Consignor agrees that the balance shall, notwithstanding, continue in full legal force and effect.
